# MINUTES AIRPORT COMMISSION

#### **JUNE 23, 2010**

Chairperson Bert Stanley called the meeting to order at 5:00 p.m. Members present were Troy Caldwell and Steve Brown. Absent were Gene Beavers and Steve Whitcomb. Also present were Renee Eckerly, City Administrator; Chuck DeWolf, Bolton & Menk, Inc.; and Stephanie Hormann, Cable Coordinator. Ron Mergen was absent.

Motion was made by Caldwell to approve the minutes of the May 26, 2010 Airport Commission Meeting. Seconded by Brown and unanimously carried.

#### REFUSE

Eckerly reported that there has been a request from one pilot to provide a refuse receptacle at the hangar. Mergen had explained to the interested pilot the problems this may cause and the need to increase the rent amount. The Commission discussed this and consented that a refuse container is not needed and would generate issues.

### **2010 FLY IN**

Eckerly distributed a sample flyer and a few additions were made. These flyers need to be distributed around town and to the airports ASAP. It was suggested to use both flyers. The Commission reviewed the Task List; it looks good and everything seems to be on schedule. The Commission discussed whether the full menu of: scrambled eggs, sausage links, fried potatoes, cinnamon bread, orange juice, and coffee should be listed. It was suggested to confirm the prices with Whitcomb. Flyers should be sent to the St. Cloud radio stations and the Alexandria TV station. Eckerly reported that the FAA permit has been received.

# LAND REIMBURSEMENT LETTER

Willmar is spending the money on the airport without paying the funds to the State. It was suggested to contact Willmar and ask how they interrupted their payback. Eckerly reported that Senator Fischbach is willing to come with representatives from MnDOT Aeronautics for a meeting with the Council and Commission.

#### **2011 BUDGET**

Eckerly reported that the City is planning for large LGA cuts and the Fly In right now for 2011 has been cut. The Commission will be kept aware (monthly) of the budget status.

There being no further business the meeting was adjourned at 5:25 p.m.



#### Dear Ron,

As you are aware, the MPCA has issued a new NPDES/SDS General Storm Water Permit for discharges of stormwater associated with industrial activity. As a result of this action, all airports are required to obtain permit coverage and are also required to develop a Stormwater Pollution Prevention Plan (SWPPP). Therefore, the City is required to obtain coverage for the Paynesville Municipal Airport.

Based on the above information, the estimated engineering budget associated with assisting the City in obtaining permit coverage is \$5,000.00. The work involved in the process will include assisting the City in the preparation of permit documents and application forms and the preparation of a SWPPP for the airport. The preparation of the SWPPP will include the following:

- Develop a facility map identifying drainage areas and individual off-site discharge locations.
- 2. Review, identify, and document all surface waters (including wetlands) within 1-mile of the facility boundary.
- 3. Review of all significant materials and pollutants stored or used onsite.
- 4. Develop facility and stormwater best management practices (BMP's) inspection requirements and schedule.
- 5. Identify stormwater discharge monitoring locations and evaluate for possible discharges other than stormwater.
- 6. Develop stormwater discharge monitoring requirements and schedule.
- 7. Develop a preventative maintenance program for stormwater BMP's.
- 8. Develop a spill prevention and response procedure.
- 9. Develop and implement an employee training program.
- 10. Develop and adopt a mercury minimization plan, if required.
- 11. Develop a program to document all existing stormwater BMPs and future modifications to existing BMPs as well as any newly listed materials or activities.
